ANNUAL MEETINGS DETAILS (18TH – 21ST MARCH 2019)

The Annual Meeting is IFHE's brings together active members from all over the world. This year's highlight is a **Press Conference** organised by CAHE on the occasion of the celebration of World Home Economics Day. Moreover, the meeting offers the opportunity to intensify the preparation for the World Congress 2020 in Atlanta. The **Programme Committees** already outlined their planning for Atlanta during the 2018 IFHE Meeting in Khartoum, Sudan and will continue to prepare specific Programme Committee sessions during the Congress. When registering, you will be asked in which of IFHE's Programme Committees you want to participate (please attend only one, they are held at parallel times).

Programme Committees (PC) are based on interest and needs and were established in 1980. They are a valuable tool for global exchange on research and work processes. Membership on the Committees consists of interested members of IFHE who are willing to actively participate and attend meetings. PCs establish objectives for a four year period coinciding with a President's "Plan of Action", the Chair reports on PC activities at the Annual or Council Meeting.

Thematic workshops take up relevant topics for Home Economists and invite members to present the rich variety of perspectives of Economists worldwide (topics to be determined). Meetings of IFHE Members from all **regions** as well as meetings of **IFHE Country Liaisons** provide excellent opportunities for networking.

Each of the federation's five **regions** (Africa, Asia, the Americas, Europe and Pacific) is directed by a Regional Vice -President and Regional member who are elected within the Region. Participants are members from the regions who discuss issues concerning their region, conduct elections and arrange meetings within their region. **Liaison Officers** represent one or several countries. Their task is to communicate with the IFHE Office, welcome new national members and collect IFHE Membership Fees in their country. At this meeting, news and new processes referring of interest to Liaison Officers are discussed.



The Annual Meeting includes working sessions of the IFHE **Executive Committee** and Congress Committees. Important results are discussed with all IFHE Members in a **Plenary Session** on the last day.

The **Plenary Session** provides the opportunity to learn about general IFHE Activities, Congresses or Councils as well as hear reports from the Committees. Every participant is invited to attend the Plenary Sessions.

The **Executive Committee** meeting is open to its members only (IFHE Acting President, Treasurer, Regional Vice-Presidents, one Executive Committee member from every region, and the Executive Director). Council Committees support specific affairs of the federation. Only appointed IFHE Members attend Council Committee Meetings.

Tour 4 A: Nature vs. Nurture (21st March 2019)

Not your usual Caribbean island, our capital is now mixed with modern and historical architecture. Explore the streets, buildings, special landmarks and our national museum during this tour.

Price: USD 90 (incl. ground transportation and entrance fees).

Take a trip on a yacht to view the small islands off the coast of Trinidad. A day of island living to visit the Gasparee Caves and lunch on the beach.

How to get to Trinidad

Book early to avoid the post Carnival Season.

Major international Airlines serve one of Trinidad and Tobago's international airports: Piarco International Airport in Port of Spain, Trinidad (POS) and ANR Robinson International Airport in Scarborough, Tobago (TAB) with ferry service to Trinidad.

Direct travel is offered from London (no US Visa required), from JFK New York or Miami with connections to all major cities in the USA, from Toronto connecting to all major cities in Canada and from Frankfurt, Germany to Tobago with connections to Trinidad.
