HEALTHY DIETS FOR A #ZEROHUNGER WORLD: IFHE JOINS 2019 WORLD FOOD DAY CAMPAIGN

diets" presented a great opportunity to promote the value of nutrition education and research. IFHE members looked back on a long-standing commitment for healthy diets and a sustainable living for all and gladly joined the campaign.

16th October was World Food Day. Its 2019 theme "Healthy and sustainable

Achieving Zero Hunger is not only about addressing hunger, but also about nourishing people, while nurturing the planet. The Un Food and Agriculture Organisation FAO annually celebrates World Food Day to promote worldwide awareness and action for those who suffer from hunger. The 2019 theme "Healthy diets for a #ZeroHunger world" aimed to increase awareness about what we eat and make healthy, sustainable diets affordable and accessible.

Healthy diets: A concern of Home Economists worldwide

Food security, nutrition and nutritional health is a key topic in Home Economics, Family and Consumer Sciences and Human Ecology. It is an integral part of our goal to foster sustainable practices at household level and achieve an optimal living for all. Ending all forms of malnutrition is closely related to a micro-level household perspective where food production and food consumption are closely interlinked. Early 2019, IFHE published a statement that highlights these aspects, interpreting the United Nations Sustainable Development Goal (SDG) no. 2 "Zero Hunger" from a specific Home Economics perspective.

IFHE members joined WHED 2019 campaign

IFHE called on its members in almost 60 countries to actively join this year's World Food Day campaign and promote the value of nutrition education and research in their working environment, especially Home Economics educators were invited to enrich their curriculum with toolkits available at the FAO website.

As Home Economists, we share the FAO belief that affordable solutions exist to reduce all forms of malnutrition. But we all know they require greater global commitment and action. IFHE members have long been promoting healthy diets and a sustainable living for all, so let's continue our good work.







FROM DISPOSSESSION

IFHE submitted a statement to the 58. Session of the United Nations Commission on Social Development (CSoCD). It picks up on IFHE World Home Economics Day theme 2020 on the same subject and members' contributions. Read excerpts of the statement drawn up Peggy O'NEIL, Canada.

The right to land upon which a home may be sustained is a fundamental human right and essential to human flourishing (...). The most significant inequalities and pressing challenges to addressing homelessness and ensuring social protection for all manifest in one of the world's poorest and most vulnerable populations, women in (...) the Global South. (...) The social protection measures put forward by the International Federation for Home Economics are primarily targeted at economic policy reform and intervention.

Major drivers of women's homelessness

The major drivers of women's homelessness through dispossession in the Global South are national economic shifts toward state industrialization of agricultural and aquaculture land and resources in partnership with transnational corporations and creditors. Economic agreements between governments and international investors denationalize and privatize land historically controlled by customary law in which women had shared use of property and natural resources (...) Women's ineligibility for title rights and related sources of income combined with their exclusion from negotiations for resettlement further depletes their limited, customary economic status and feminizes homelessness in the Global South.

Priority areas for intervention

One of the most exacerbating factors mitigating social development coincident to economic growth are long term, outstanding legal claims and delayed court rulings over unfulfilled promises. (...) Education is another contributor to feminized homelessness because women do not always possess necessary literacy levels to negotiate, keep records, or, to take legal action. (...) Adequate housing provides a source of protection, security and connection for women and their children and feminized homelessness or excessively gendered tenure puts women in a position in which they cannot (...) care for or fight for their children.

IFHE policy recommendations to address feminized homelessness

The International Federation for Home Economics proposes (....) policy recommendations to address feminized homelessness in the Global South. First, providing a voice to homeless women through qualitative inquiry. Second, introducing or expanding existing international economic policies to explicitly include resettlement, rehabilitation, restitution, and resolution requirements for investors participating in and enjoying the benefits of United Nations-affiliated credentials for sustainable asset management.









BEIJING+25: REALIZING GENDER EQUALITY AND THE EMPOWERMENT OF ALL WOMEN AND GIRLS

9-20 March 2020

25TH ANNIVERSARY OF BEIJING PLATFORM FOR WOMEN'S RIGHTS

2020 marks the 25th anniversary of the Beijing Platform for Action, a milestone for advancing women's rights. IFHE joined ranks with other NGOs to demand that governments increase their ambition towards the realisation of areas identified in 2000 and celebrates by inviting its members to attend the anniversary session at the United Nations (see box left-hand side).

The 4th World Conference on Women in September 1995 focused on gender equality and the empowerment of all women. By the time the conference closed, it had produced the Beijing Declaration and Platform for Action, the most progressive blueprint ever for advancing women's rights. On the occasion of its 25th anniversary, IFHE joined ranks with other INGOs to remind governments to step up action towards the realisation of the Beijing Declaration.

Graduate Women International (GWI): Education for girls and young women

IFHE cooperated with Graduate Women International (GWI), an NGO that has a long history of promoting women's education. GWI advocates for women's rights, equality and empowerment through access to quality secondary and tertiary education and training up to the highest levels. Their vision is 100% of girls and women in the world achieving education beyond primary school. Like IFHE, GWI has organisational and individual members in 60 countries. IFHE and other NGOs holding UN consultative status endorsed a GWI drafted statement to be submitted to the anniversary session of the Commission on the Status of Women in 2020.

IFHE supports demand for post-primary education for girls and young women

The statement highlights that post-primary education gives girls and young women the academic and personal tools vital to progressing further in higher education, work and society; equips them with high-level academic knowledge and qualifications; enables the uptake of professional positions and increases earning potential; enhances social inclusion and personal development; and is both, a means of empowerment and an investment in tomorrow's future leaders and decision-makers.

BREAKING BARRIERS IN EDUCATION: HOME ECONOMICS AT UNESCO CONFERENCE

UNESCO held its annual Strategic Debates in Paris, France on 24 October 2019. Mona Sharaf ABDELGALIL who represents IFHE at UNESCO, was invited to attend. Read her report about the conference and its important outcomes.

The Strategic Debate was organized by the International Institute for Educational Planning (IIEP), who is part of UNESCO and the only institute in the world providing a winning combination of training in educational planning, cutting edge research and in-country capacity development for educational bodies. It focused on the new Abidjan Principles.

Abidjan Principles 2019: Turn right to education into practice

The theme was how to take the right to education seriously by looking at the new Abidjan Principles on human rights, a milestone tool on the path to turn the right to education into practice, and its potential to address the crucial questions of how to address education in a world that is constantly changing, where climate and migration emergencies are fast rising, and where private actors are taking on a more prominent role. The Abidjan Principles were defined and finalised by a group of eminent independent experts from around the world in 2018 and were adopted in Côte d'Ivoire on 12-13 February 2019. The Abidjan Principles promise to be the new reference point for governments, educators and education providers when debating the respective roles and duties of states and private actors in education.

The presentation of the principles was made by two experts: Mr. Sylvain AU-BRY, from the Global Initiative for Economic, Social and Cultural Rights and Ms. Delphine DORSI from the Right to Education Initiative. They focused on the right to education and how policy-makers and education planners can use them.

AFRICAN REGIONAL CONFERENCE HELD IN LUSAKA, ZAMBIA

The Home Economics Association of Zambia hosted the 9th African Regional Conference and, at the same time, its national conference in Lusaka, Zambia from 26th to 30th August 2019. Read the report of Nigerian participant Felicia Titilayo ADENIGBA.

The Home Economics Associations in Zambia (HEAZ) hosted the joint 9th IFHE African Regional Conference and 46th HEAZ National Conference. The theme of the conference was "Home Economics: Multi-disciplinary strategies for achieving sustainable development across Africa and beyond". The venue of the conference was National Science Centre, Lusaka, Zambia.

The Conference attracted Home Economists from various District of Zambia and other African countries such as Nigeria, South Africa, etc. The welcome address was delivered by Professor Patricia Etuna MBAH, IFHE Vice President, Patricia PHIRI, President of the Zambia Home Economics Association (HEAZ) and Dr. Chishala H. LUPAMB, L.O.C Chair.

A keynote address was presented by Prof. Hester Steyn, IFHE Representative and former IFHE Executive Member. In her speech, she emphasized the importance of participatory interest and total involvement in sustainable development as crucial in Home Economics for the achievements of sustainable development across Africa and beyond.

About twenty-seven research papers on various fields of Home Economics were presented. There was also a presentation on the benefits of usage and production of coconut oil by this report's author Felicia Titi Adenigba. There were various exhibitions on different income generating activities to create a sustainable future in developing countries. The conference had a huge turnout and there were also guests from the Education Permanent Secretary, Office of the Minister and other ministries Lusaka. Fifteen members attended from Nigeria.







IFHE PROMOTED AT INTERNATIONAL CONFERENCE AT HELWAN UNIVERSITY, EGYPT

Mona Saraf ABDELGALIL, IFHE EC member and Liaison Egypt, represented IFHE at the 5th International Conference of Faculty of Home Economics at Helwan University. Read a summary of her account of how IFHE representative promoted our work amongst the conference participants.

The conference was titled "Home Economics & Sustainable Development Challenges in Africa" and was held under the patronage of the minister of Higher Education & Scientific Research Egypt and was held in presence of the Ambassador of the State of Chad in Egypt and the Cultural Attaché of the State of Libya.

In a written welcome address and recorded voice message, EC Vice-President Africa Patricia MBAH welcomed delegates and emphasized on the importance of such an international and regional forum, as it provides useful opportunities for both, academic and social networking and contributes a Home Economics perspective in sustainable development. The conference is a way of getting interested Home Economists as participants in tackling and dealing with issues that would change the family and the nations at large.

In her welcome address, EC member Mona ABDELGALIL thanked Prof. Ashraf Abdelaziz, former dean of the faculty, for his kind invitation for IFHE. She then mentioned that the conference corresponds to the ultimate goal of IFHE which is the improvement of the quality of everyday life for individuals, families and households through the management of their resources. The most important issue within developing countries in Africa is the access to education, as it is difficult to compete in a global economy with an undereducated, low skilled workforce and as a result the countries remain poor. Another issue is the lack of quality housing. Often, people live in overcrowded conditions and/or in poorly constructed homes. This leads to problems with diseases, crime, and the safety of the structures in which the people live. Mona ABDELGALIL also used the IFHE presentation to explain about our work and highlight the benefits of becoming a member.
