IFHE ADVOCATES FINANCIAL POLICY REFORM TO ALLEVIATE FEMINIZED HOMELESSNESS

Homelessness: World Home Economics Day theme 2020

Log in to the member area to find useful material to prepare your WHED celebrations. IFHE officials attended the United Nations 58th Session of the Commission for Social Development to advocate social protection for all against homelessness. Read a summary of the IFHE position by Peggy O'NEIL, Canada.

Homes are environments where individuals reach their full potential, live a life of dignity, and develop and express their global interdependence. The commercialization and privatization of customary land in the Global South disadvantages women, renders them homeless and interrupts their livelihoods. IFHE welcomed the opportunity to work together with the United Nations Commission for Social Development (CSoCD) on the 2020 priority theme "Affordable housing and social protection systems for all to address homelessness".

IFHE representatives asked United Nations affiliated financial institutions to review and reform signatory eligibility and compliance policies in order to strengthen and uphold provisions to mitigate feminized homelessness in the Global South. In personal wealth management and income tax reduction planning, individuals can help by making sure fund companies in their portfolios comply with social sustainability standards.

Impact of housing on women and families

"Engaging in this international forum is important for IFHE because of the impact that housing has on women, families, and our future. That's why we are here at the UN this week," said Dr. Sandra Poirier, Professional Home Economist and Professor, Middle Tennessee State University, USA.

Evidence and experience indicate that one of the most significant inequalities and pressing challenges to addressing homelessness and ensuring social protection for all manifest in one of the world's poorest and most vulnerable populations, women in Asia, Africa and Latin America. Economic agreements between governments and international investors denationalize and privatize land historically controlled by customary law in which women had shared use of property and natural resources for the respective purposes of building basic homes and subsistence livelihoods. The social obligations and communal arrangements under customary tenure have been particularly important for women who are more dependent upon them in order to use the land and control assets such as livestock and crops to generate income with which to build basic homes and subsistence livelihoods.

Advocating for financial policy reform

The most important social protection measure against feminized homelessness in the Global South is international financial policy reform in combination with action by investment and financial groups committed to social sustainability. International, economic policies must be reviewed and revised to explicitly include resettlement, rehabilitation, restitution, and resolution requirements of



investors participating in and enjoying the benefits of United Nations-affiliated credentials for sustainable asset management.

"Women's land rights are essential to human progress. *Everyone* needs a place to create a life—to flourish," said Dr. Peggy O'Neil, Professional Home Economist and Adjunct Research Professor, Brescia College University, Canada.

REDUCING FOOD WASTE: BEST PRACTICE TIPS TO PROMOTE THE RESPONSIBLE USE OF HOUSEHOLD RESOURCES

Did you know? 1/3 of food produced for human consumption worldwide gets lost or wasted every year. This is how the new best practice tips how to manage food and food waste catch the readers' attention. The poster was developed by experts of the IFHE Programme Committee Household Technology & Sustainability and presents the complex topic of food waste in a condensed way, explaining food waste in developing and industrialized countries and offering abundant tips how to use food sustainably in one's home.

The poster is only the latest addition to previously published best practice tips on cooking, drying, storage & refrigeration and other all daily chores that have a significant impact on the sustainable use of household technology and resources. All nine best practice posters and tips are based on peer-reviewed scientific literature. To better transport their complex message, they have now been revised and given a new design with help of our "virtual intern" Seunghee Lee who has a MFA in Environmental Graphic Design and lives in El Paso, USA.
